Sealed Tenders are invited by the Municipal Commissioner, Berhampur Municipal Corporation in conformity with Detailed Tender Call Notice (DTCN) from the Private Parties / Registered Societies / N.G.Os for " Management of Earmarked Parking Spaces on Lease Basis" for the following locations / blocks for parking of paddle Operated Bicycles & Cycle rickshaws, Push Carts and Fuel or Electric Current Operated Two Wheelers, Three Wheelers and Four Wheelers on payment of prescribed parking fees. The rate of parking fee/ charge to be collected from each Vehicle Parker has been fixed at Rs. 1/- for Paddle operated Bicycles, Cycle rickshaws and Push Carts. Similarly, the rates for Fuel or Electric Current Operated Vehicles have been fixed at Rs. 3/- for each Two Wheeler, Rs. 5/- for each Three Wheeler and Rs.10/- for each Four Wheeler. The charges have been fixed for parking over a continuous maximum period of 5 hours or less in a day. The total parking period in a day will be reckoned from 7.00 a.m. to 10.00 p.m. and in all the 7 days of each week.
