1. Interested agency/NGOs/Animal Welfare Organization (AWOs) with certified Veterinary Doctors having registration with Veterinary Council of India/Animal Welfare Board for sterilization and immunization of stray Dogs under Animal Birth Control (ABC) Programme may apply.
2. Necessary infrastructure for the purpose will be provided by the BeMC and CDVO, Ganjam
3. Interested Organization may send their technical and financial document details in the hard copy to Commissioner, Berhampur Municipal Corporation, Berhampur through speed post or by hand, with eligibility and application on or before Dt. 15/10/2018. The financial bid should be made for complete process including sterilization and vaccination, and upkeep for 05 days for single case and enclosed in a sealed envelope, along with technical bid.

**Inviting Animal Welfare Organizations AWOs/NGOs for Sterilization &  
immunization of Stray Dogs in Berhampur under Animal Birth Control (ABC)  
Programme**

1. Interested NGOs/Animal Welfare Organization (AWOs) with certified Veterinary Doctors/retired veterinary doctors, having registration with Veterinary Council of India/Animal Welfare Board for sterilization and immunization of stray Dogs under Animal Birth Control (ABC) Programme may apply.
2. The AWOs/ NGOs should have adequate staff (technical & non-technical) and preferably vehicles as well for picking up and releasing of sterilized dogs back to the same area from where they had been picked up.
3. All interested AWOs/NGOs shall have to undertake the work of sterilization and immunization of stray dogs as per the Animal Birth Control (Dogs) Rules 2001 and Standard Operating Procedures for sterilization and Immunization of stray dogs issued by the Animal Welfare Board of India (AWBI).
4. The Organization would have to abide by the rules & regulations of Animal Welfare Board of India and Govt of India, issued/amended time to time regarding Animal Birth Control Programme.
5. The organization will cover all areas of Berhampur. However, the area/zone from where the stray dogs would be picked up for sterilization and immunization shall be allocated by Authority.
6. The payment of the cost of sterilization of stray dogs shall be reimbursed as per rates approved by the BeMC from time to time after verification and counting of genital organs of dogs sterile, by a Joint Inspection Team. Certification by CDVO.
7. AWOs/NGOs- interested to be associated with the programme for sterilization and immunization of stray dogs may send their application with all required details in hard copy to Commissioner, Berhampur Municipal Corporation as per the enclosed Performa.
8. The last date for submission of application is Dt. 15/10/2018

9. The interested AWOs/NGOs may also submit the additional information relevant to the work in addition to the information sought in Performa.

10. If Berhampur not satisfied with the work of sterilization, Bemc and CDPO may ask the applicant to stop the work by giving him a one month notice.

11. The supporting infrastructure will be provided by the BeMC and CDVO.

12. The financial bid should be made for complete process including sterilization and vaccination, and upkeep for 05 days for single case and enclosed in a sealed envelope, along with technical bid.
