EXPRESSION OF INTEREST FOR SETTING UP COLLECTION CENTRE FOR PLASTIC WASTE MANAGEMENT

Berhampur Municipal Corporation (BeMC) invites expression of Interest from Individual, Sole Proprietorship concern, Partnership Firm, Registered Society/Registered Co-operative Society, Public Limited Company or a Private Limited Company for setting up Collection Centre of Plastic Waste Management and engaging Ragpickers for waste management.

The bidder should submit the followings as detailed below:

1. The Bidder shall submit credibility and experience certificate from any concerned authority / employer of a Govt. / ULB / PSU of repute / Corporation in similar nature of business/trade, or proof of having a processing facility for Plastic Waste. The facility, capable of making items like button, T-shirts, etc. by utilising plastic waste will also be considered.
2. The agency shall submit proposal on establishment of collection centre and processing unit with the engagement of rag-pickers, citizens and BeMC. The total cost for the same shall borne by the agency. The collection centre to be in Odisha and Processing Unit can be anywhere in India.
3. The Agency shall conduct training and capacity building of rag-pickers for waste management
4. Interested Agency should quote prices paid against the plastic waste collected by Ragpickers or supplied by citizens or BeMC.
