The Government of India has received financing from the World Bank towards the cost of the Odisha Disaster Recovery Project (ODRP), and intends to apply part of the proceeds for engagement of External Auditor for ODRP, BeMC for the Financial Year 2014-15 to 2016-17.

The consulting services ("The Services") will include the audit of the Project Financial Statements (PFSs) of various urban infrastructure projects of component 2 of ODRP such as improvement of roads, drains, water supply projects and the slum infrastructure works in Berhampur city area at the end of each fiscal year, and on funds received and expenditures incurred for the relevant accounting period as well as to express an opinion on the eligibility of the expenditure under the project. The audit also involves review of the audit reports prepared by the internal auditors for the project.

ODRP, BeMC wishes to engage qualified Audit Firms (preferably CAG empanelled firms) with proven track record and relevant experience in providing services for projects of similar nature and size (preferably World Bank funded project). The consultants should be staffed with experts having deep knowledge and experience in financial management, familiar with the Bank's Guidelines on Annual Financial Reporting for World Bank-Financed Activities, June 30, 2003, which summarizes the Bank's financial reporting and auditing requirements.
