The Commissioner, Berhampur Municipal Corporation invites sealed Tenders from any Advertising Firms/ Company for "Auction of Advertisement space and Cleaning of Solar Powered Bus Stop" for Berhampur Municipal Corporation.

The Start and end date of sale of Tender from 30-11-2018 to 10-12-2018. Tenders should reach the undersigned on or before 12-12-2018 by 5.00 PM through Regd. Post/Speed Post and will be opened on 13-12-2018 at 11.30 AM in the office chamber of the undersigned in presence of the tenderer or their authorised agents who intend to attend. The bidder who quotes the highest rate will be awarded. Conditional tenders will be rejected immediately. The rate should be written clearly and legibly without any error or overwriting and both in figures and in words. In case of difference or rates or any ambiguity over rates, then the rates written in words will be taken into consideration.

BeMC has established two Solar powered Bus stop in BeMC area. The Size of the Bus stop is LWH(7x2.5x2.6). There are two LED powered Display Boards (Dual Face) of size 1.80 x 1.30 Mtrs in each Bus stop.

Scope of the Work and Mandatory Guideline:

- The contract is valid for a period of 3 years.
- The bidder must have prior experience in similar field.
- The Scope of the work includes Advertisement, Cleaning and maintenance of the Solar powered bus stop.
- The Technical damage of Solar and LED equipments will be covered by the executing agency for a period of 3 years.
- Any physical damage of the Bus stop will be bear by the Bidder.(Successful bidders are encouraged to go for insurance).
- Each Bidder should furnish bid cost of Rs. 4480/(including GST) in shape of DD in favour of Commissioner, Berhampur Municipal Corporation and E.M.D. of Rs. 5,000/- (Rupees Five thousand) in shape of Demand Draft in favour of Commissioner, Berhampur Municipal Corporation.
- The bidder has the right to advertise at his own discretion which should not violate the Rules and regulations made by Govt. Of Odisha.
- The bidder should submit the Firm Registration, GST Registration, PAN Card
- The bidder who quotes highest will be awarded the work.
- The one year contract value should be deposited by the successful bidder in advance in each year.
