- The cleaning of road including lanes and by lanes will be done twice a day from 4.00 a.m. to 9.00 a.m. & 3.00 p.m. to 6.00 p.m. as per the direction of Health Officer / Commissioner.
- There should be minimum 40% of the sweepers strength should be male.
- The Drains should be cleaned & de-silted regularly.
- Disinfection, such as bleaching powder / Mosquito oil should be sprayed supplied by BeMC.
- The Tenderer should arrange Nos. of Labourers as indicated and would pay wage Rs. 200/- per day to each Labourer.

- The tenderer should provide two nos of uniform floursent jackets to each labourer of Navy Blue colour.
- The Corporation will provide vehicles, wheel barrow and Tricycles.
- Cleaning equipments such as Jhadu, Sura, Belcha, Spade, Angle Canta, Crow Bar, Knife etc. will be supplied by the tenderer as per requirement.
- When ever the Govt. of Odisha will enhance the minimum wages the Authority shall pay the differential amount of enhance wages to the Firm / Agency / Organization with respect to the numbers of labours engage ward wise.
