## **EXPRESSION OF INTEREST FOR MANAGEMENT OF EARMARKED PARKING SPACES ON REVENUE SHARING BASIS**

Berhampur Municipal Corporation (BeMC) invites expression of interest from Mission Shakti Groups for management of earmarked parking space as per the list enclosed on revenue sharing basis with following criteria.

1. For parking of paddle operated bicycles & cycle rikshaws, push carts and fuel or electric current operated two wheelers, three wheelers and four wheelers on payment of prescribed parking fees.
2. The rate of parking fee/charge to be collected from each vehicle will be fixed by BeMC.
3. The proposal/application should be submitted along with registration certificate of the Mission Shakti Groups.
4. For any clarification you can contact Commissioner Office during office hours.
5. The corporation has right to reject proposal without assigning any reason thereof.
6. Interested Mission Shakti Groups may send their proposal application by hand or registered post to Commissioner, Berhampur Municipal Corporation, Berhampur through speed post or courier or by hand before 12.01.2022 by 5.00 PM.
7. The period of engagement is for one year and will be extended based on performance.
8. 60% (sixty percent) of this revenue generated will be retained by BeMC and the rest 40% (forty percent) will be disbursed to the SHG as their income share.
