The prices shall be inclusive of all taxes (Direct or indirect) levies, duties, freight, insurance etc for Berhampur, Odisha and shall include all charges and incidentals for successful commissioning. No extra custom, state entry tax, any other tax will be paid. The statement saying "However custom and state entry tax shall be paid extra to the firm as per actual against documentary proof" is deleted.
