Soon after the declaration of the result, the highest offerer shall deposit 25% of the bidding cost immediately in shape of cash at Corporation Treasury and balance amount of bidding cost should be deposited within seven days from the date of issue of acceptance order. The lifting order will be issued after deposit of full acceptance amount & GST (which will be taken into account as applicable) on submission of challan/receipt. Corporation will not take risk towards watch & Ward of the said Vehicle/Machinery. However ground rent 1(One) % will be charged after expiry of one month from the date of lifting order. After completion of the said one month, if qualified bidder is found to have not taken goods, the same Vehicle/Machinery will be reauctioned and the deposited amount and the E.M.D of the highest offerer will be forfeited.
