
QUOTATION CALL NOTICE

Letter No. 8716/XXIX(E.9)9/22

Sealed quotations / tenders are invited from the interested Owner / Agencies for providing of 3 wheeled (4 speed) Static Road Roller of 8-10-ton capacity of reputed brand (ISI) mark for use of BeMC on monthly hire basis for the period of 1 year which shall confirm to the term and condition (Annexure – II).

1. The Road Roller must be in road worthy & good condition, shall not more than 5 to 6 (five to six) year old from the date of manufacture.
2. The engine power should be 37 to 42 HP.
3. The Rolling width of Road Roller should have 1800 to 1850 mm with 100 mm overlapping Rear Roll.
4. The driver of the Road Roller must have a valid driving licence and should have sufficient experience in driving the Road Roller.
5. The driver should be well behaved, gentle and obedient in nature.
6. The monthly rate of hire charges are to be quoted separately including driver, applicable taxes and all repair & maintenance cost (excluding fuel) in the general bid information.
7. The details of the Make and year of manufacture, mileage (Litre per hour or km) and name of driver with driving licence no & period of validity.
8. The quotation should reach the undersigned on or before 28/10/24 up to 3.00 P.M through Speed post / Registered Post only. The quotation will be opened on the same day at 4.30 P.M in presence of the bidder or their authorized representative, if any.
9. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of A/C payee bank draft / Demand draft / Pay order drawn in favour of the Commissioner, Berhampur Municipal Corporation and submitted along with the tender / quotation as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
10. The application form of quotation / tender containing general bid information and term & condition for hiring of Road Roller will be available with vehicle section of Berhampur Municipal Corporation on payment of Rs. 4000/- +GST (18%) (Rupees four thousand seven hundred twenty) only to be deposited at office A/C from 7/10/24 to 25/10/24 or can be downloaded from website www.berhampur.gov.in. The bidder should submit the security deposit, tender paper cost in shape of B.D/DD/Bankers cheque drawn in favour of the commissioner, Berhampur Municipal Corporation or challan showing the deposit at corporation campus HDFC bank.
11. The quotation / tender should be superscribe on cover that "Tender/Quotation for Hire Road Roller".
12. The owner / bidder should submit the PAN Card, Proof of Road Roller with the quotation / tender.
13. Authority reserves the right to accept or reject any or all quotation / tender without assigning any reason thereof.



TERMS AND CONDITIONS FOR HIRING OF ROAD ROLLER

The following terms and conditions must be fulfilled by the successful bidder for providing the Road Roller on monthly hire basis.


1. The hired Road Roller shall have valid insurance certificate and D.L of driver available all the times. The BeMC shall not be responsible for any damage / loss caused to hired Roller or loss of life/ injury made to any person or damage to any property on account of upon of roller any manner whatsoever. The hirer shall not be responsible for all such litigation (The bidder shall be responsible for all such litigations).
2. The hire charges to be paid for monthly basis is final but does not included cost of diesel. The diesel will be issued separately or reimbursed basing on actual consumption as certified / tested by A.E.E (Mech). All the expenditure of the Road Roller towards repair, replacement of spare parts, Lubricating oil of engine, Gear box, Differential, Coolant, Battery etc will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner/bidder.
4. In case of breakdown for reasons whatsoever, the replacement of a Roller of the same or better model shall be provided by the owner/bidder.
5. In case of the Road Roller do not report regularly/timely or unsatisfactory service the authority will be the liberty to disengage the Roller and may engage another one from other source.
6. The Road Roller should report for duty minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer, no extra payment shall be demanded by the owner/bidder.
8. The Road Roller shall be of reputed ISI make/brand not more than 5 to 6 years old from the date of manufacture and also on good running condition during the entire period of contract (Proof should be enclosed).
9. BeMC may issue work order or engagement order on phased manner.
10. The quote should be including all taxes duties, all minor & major repair and driver / operator.
11. In case, the owner/bidder intend to withdraw the service of his road roller, it shall be mandatory upon him to grant fifteen days notice before such withdrawal of service.
12. If the owner/bidder violates any of the terms & condition, BeMC shall forfeit the security deposit.
