The Berhampur Municipal Corporation invites sealed Quotation from registered Agencies/ firms from Odisha through Regd. Post/ Speed Post in two bid system for **"Supply and Installation of AC in the 1st Floor Conference Hall of BeMC"**.

The Start and end date of sale of Quotation from 24-02-25 to 04-03-25. Physical Quotation should reach to the undersigned on or before 06-03-25 by 5:00 PM and will be opened on 07-03-25 at 11:30 AM in the office chamber of the undersigned in presence of the quotationer or their authorised agents who intends to attend. The rate to be quoted shall be inclusive of Installation, handling and transportation / delivery charges (Excluding GST)). No extra cost on any account whatsoever will be admissible. Conditional quotations will be rejected immediately.

The Technical and Financial Bid should be submitted in two different Cover Superscribing as TECHNICAL DOCUMENTS and FINANCE DOCUMENTS respectively and put in a Single cover superscribing **"Supply and Installation of AC in the 1st Floor Conference Hall of BeMC"** The rate should be written clearly and legibly without any error or overwriting and both in figures and in words. In case of difference or rates or any ambiguity over rates, then the rates written in words will be taken into consideration.

Prequalification for Technical Evaluation:

Each bidder should furnish the following documents with the Technical Bid.

1. Bid Cost of Rs. 7080/- (non-refundable) in shape of DD in favour of Commissioner, Berhampur Municipal Corporation.
2. EMD of Rs. 22,000/- in shape of DD in favour of Commissioner, Berhampur Municipal Corporation.
3. Bidder should have OEM Authorisation specific to this Tender.
4. GST Regn.
5. PAN Card.
6. Bidder must have 1cr minimum average turnover in last 3 FY 2021-22, 2022-23 and 2023-24 with ITR and last 2 months GSTR return copy attached. Turnover certificate on CA letterhead.
7. The Product Compliance sheet must be on OEM Letterhead with the company seal & signed by the local Partner Business Manager.
8. The bidder must have a registered office in the state of the Consignee location for faster and better Service, Support, and Documentary Proof to be uploaded along with the BID Documents.
9. Bidder should work with Govt. in similar nature along with copy of previous orders and credentials issued by any Govt. Office/ Organisation in favour of him/her/them.
10. Undertaking for non blacklisted from any govt/psu on letterhead.
11. Bidder should submit the Catalogue for the Products quoted.
12. All documents should be ink signed stamp properly.




