

BID PAPER

1. The Bidder should submit the photocopy of PAN & GST along with the quotation.
2. The Successful bidder shall have to install temporary shed at each location with provision of earthen water pots, glasses, fixing of banner and manpower for distribution of drinking water from 9.00 AM to 5.00PM daily with effect from 20.03.2025 till further order.
3. Berhampur Municipal Corporation will provide the drinking water to all the Jalachhatra Centers.
4. Total numbers of Jalachhatra Centres will be around 70. The number may vary while issuance of work order. The location of Jalachhatra Centers will be provided by BeMC.
5. The payment of bill towards Services shall be paid to the successful bidder only after satisfactory performance report by the authorized officer of BeMC.
6. All grievances in respect of functioning of Jalachhatra shall be attained by the bidder within 24 hours otherwise penalty @Rs. 100/- per day shall be deducted from the amount raised for the Jalachhatra concerned.
7. The lowest quoted rate in cumulative will be considered.
